

# SEDAR® Subscriber Update

June 23, 2008

## Code Update (Version 008.008.000)

A SEDAR code update is scheduled for Monday, June 30, 2008.

You are encouraged to obtain the code update as soon as possible on or after June 30, 2008 by following these procedures:

1. Start the SEDAR program;
2. Select File menu; and
3. From the File menu, select Receive items from SEDAR server.

This method will help make sure that the application is updated and ready for your use before you actually have to perform any business functions.

This code update will bring the SEDAR client application up to Version 008.008.000.

Once the code update has been downloaded, close the SEDAR program and follow the instructions below to execute the code update:

1. Click the Start button located at the bottom left corner of the screen;
2. Select Programs; and
3. From the Program menu, select SEDAR and then select Code Update.

## Summary of Code Update Changes

### 1. Filing Type and Subtype

The following filing types have been added to the Continuous Disclosure / General folder for Other Issuers:

- Annual Information Forms\*
- OTC Issuer Cease to be a Reporting Issuer

*\*NOTE: Going forward, issuers who are required to file an annual information form under NI 51-102 and issuers filing alternate forms of AIFs such as in Form 10-K, 10-KSB or 20-F should use the filing type: "Annual Information Forms".*

*Investment Fund issuers who are required by NI 81-106 to file an annual information form should continue to use the filing category "Annual Information Form (NI 81-106)".*

*The CDS continuous disclosure fees applicable to the filing of the Annual Information Form (NI 51-102) will now be charged with the submission of the new filing type "Annual Information Forms."*

The following filing type has been removed from the Continuous Disclosure / General folder for Other Issuers:

- Annual Information Form (NI 51-102)

Two new subtypes have been added to the filing type “Long Form Prospectus” (Investment Funds / Securities Offerings):

- Combined Preliminary and Pro Forma
- Amendment to Preliminary or Combined Preliminary and Pro Forma\*

\*NOTE: *This subtype replaces the previous subtype “Amendment to Preliminary”.*

## 2. Document Type

The new document type “Calculation of earnings coverage” has been added to the following filing types:

Other Issuers

- Interim Financial Statements
- Annual Financial Statements

New document types have been added to the “Proxy Solicitation Materials” filing type (Third Party Filers / Third Party Filings):

- Proxy solicitation information – English
- Proxy solicitation information – French
- Proxy solicitation – proposed transaction - English
- Proxy solicitation – proposed transaction - French
- Proxy solicitation – nominee for election – English
- Proxy solicitation – nominee for election - French

## 3. French Rule References

Folder, Subfolder and Document names that referenced “NC” (Norme canadienne) have been replaced with “Règlement” because almost all National Instruments are Regulations in Québec.

## 4. Cover Page

The mandatory field *Filing Procedures* has been restored to Page 2 of the Issuer cover page for new filings. The field allows for the selection of either one or a combination of any two of the following:

- MI 11-102 Passport System and NP 11-202
- NI 44-103 PREP Procedures
- No elective filing procedures applicable

The *Continuous Disclosure Rule* drop-down field on the General cover page has been removed from most filing types. The field will remain on the following filing types (Other Issuers and Investment Fund Issuers):

- Interim Financial Statements
- Annual Financial Statements

## 5. Issuer Profiles

A new mandatory field "*OTC issuer*" has been added below the *Jurisdictions where Reporting Issuers* field. All existing Other Issuer profiles will be updated to reflect "Not applicable" in this new *OTC issuer* field. Filers must Refresh the Other Issuer profiles on their Profile Management list to update their local profile copy. When creating a new issuer profile, a selection must be made on this field of either "Yes" or "Not applicable".

## 6. SEDAR.com

New search options will be available under the Public Companies / Search Database function:

- OTC Issuer Filings
- Proxy Solicitation by Third Parties
