Words from the Canadian Securities Administrators:

### **Issuer Profile Update**

National Instrument 13-101 (the SEDAR Rule) requires issuers to maintain and update their SEDAR filer profile information. An issuer should ensure that changes are made to their SEDAR filer profile within 10 days of any change in the information contained in the profile.

Issuers listed on the TSX Venture Exchange should update their SEDAR profile to reflect the correct name for the exchange where the issuer is listed. Any references to CDNX-AB or CDNX-BC in the issuers profile should be updated to reflect the correct name of the exchange.

This change **can be** made in conjunction with the issuer's next SEDAR filing. Please ensure all information contained in the profile, such as contacts and addresses reflect the current information for the issuer. Failure to update filer profile information in a timely manner after a change has occurred may result in the issuer being placed on a default list.
