

# **SEDAR® Subscriber Update**

## **November 11, 2004**

### **Code Update (Version 007.001.018)**

A SEDAR code update is scheduled for Monday, November 15, 2004. Its size is approximately 4.84 MB and should take approximately 6 minutes to download using a 56 K modem.

You are encouraged to obtain the code update as soon as possible on or after November 15, 2004 by following these procedures:

1. Start the SEDAR program;
2. Select File menu; and
3. From the File menu, select Receive items from SEDAR server.

This method will help make sure that the application is updated and ready for your use before you actually have to perform any business functions.

This code update will bring the SEDAR client application up to Version 007.001.018.

Please be patient and **allow the download to complete before proceeding**. Once the code update has been downloaded, close the SEDAR program and follow the instructions below to execute the code update:

1. Click the Start button located at the bottom left corner of the screen;
2. Select Programs; and
3. From the Program menu, select SEDAR and then select Code Update.

### **Summary of Code Update Changes**

#### **1. Market Centre references in SEDAR**

##### **Filing Management**

SEDAR has been updated to reflect the current naming conventions of the Canadian market centres; wherever "CDNX" was shown in SEDAR (i.e. in filing type and document type names), the market centre reference will now show as "TSX-V".

The list of available recipient market centre agencies for future SEDAR filings has been updated to indicate only TSX Venture Exchange.

##### **Profile Management**

The list of Stock Exchanges (or Markets) on the Reporting and Markets tab of the Other Issuer profile type has been updated to reflect the current TSX and TSX-V references.

\*Any existing Other Issuer profiles that had referenced Canada – TSE and/or Canada –CDNX have been updated to show Canada-TSX and/or Canada-TSX Venture respectively.

The references to the following market centres have been deleted and will not be available for selection when creating a new or updating an existing Other Issuer profile:

- Canada - CDNX - BC
- Canada - CDNX – AB
- Canada – WSE
- Canada- ME
- Canada-CDN-OTC

\*Any **existing** Other Issuer profiles that referenced any of the above deleted market centres will continue to reference these agencies until their profile is updated on SEDAR to indicate their current market centre.

\*Any **unsubmitted** Other Issuer profiles showing their status as “In Process” or “Ready” will be updated to show “Delete”. These profiles must be either deleted or updated to reflect the new market centres before they can be submitted to SEDAR.

The following market centres have been added:

- Canada - NEX
- US – BSE; CBOE; CSE; Chx; ISE; Phlx; PCX
- CNQ
- OTCBB

## 2. Filing Types Deleted

The following filing types have been deleted from Other Issuers/ Securities Offerings. Filers can still create additional submissions for projects that were created using these filing types. However, any filings not submitted (shown as TMP on your Filing Management screen) will be flagged for deletion. Filers are encouraged to submit any temporary filings or delete them from their Filing Management screen list prior to the code update of November 15, 2004.

- Short Form Offering Document – BC

Alberta subfolder:

- Prospectus Offering - New Listing (ASC, CDNX)
- Prospectus Offering (ASC, CDNX)

- Prospectus Offering - New Listing (MSC, WSE)
- Prospectus Offering (MSC, WSE)
- Rights Offering Material (MSC, WSE)

### **3. Customer Assistance**

The Directory listing of all recipient agencies' phone numbers has been updated to provide the TSX Call Centre contact number; all other market centre references have been deleted.
