

SEDAR® Subscriber Update

January 4, 2010

Code Update (Version 008.013.000)

A SEDAR code update is scheduled for Monday, January 11, 2010.

You are encouraged to obtain the code update as soon as possible on or after January 11, 2010 by following these procedures:

1. Start the SEDAR program;
2. Select File menu; and
3. From the File menu, select Receive items from SEDAR server.

This method will help make sure that the application is updated and ready for your use before you actually have to perform any business functions.

This code update will bring the SEDAR client application up to Version 008.013.000.

Once the code update has been downloaded, close the SEDAR program and follow the instructions below to execute the code update:

1. Click the Start button located at the bottom left corner of the screen;
2. Select Programs; and
3. From the Program menu, select SEDAR and then select Code Update.

NOTE: TMP Filings

All filings that have been saved but not submitted (shown as TMP on your Filing Management screen) should be either submitted by Friday, January 8, 2010 or deleted. To delete any TMP filings, highlight the project and select File/ Remove Unsubmitted Filing(s).
