

# **SEDAR® Subscriber Update**

## **September 28, 2006**

### **Code Update (Version 008.003.000)**

A SEDAR code update is scheduled for Monday, October 2, 2006.

You are encouraged to obtain the code update as soon as possible on or after October 2, 2006 by following these procedures:

1. Start the SEDAR program;
2. Select File menu; and
3. From the File menu, select Receive items from SEDAR server.

This method will help make sure that the application is updated and ready for your use before you actually have to perform any business functions.

This code update will bring the SEDAR client application up to Version 008.003.000.

Once the code update has been downloaded, close the SEDAR program and follow the instructions below to execute the code update:

1. Click the Start button located at the bottom left corner of the screen;
2. Select Programs; and
3. From the Program menu, select SEDAR and then select Code Update.

## **3. Third Party Filings**

All filing types under the Category of Filer “Third Party Filers” will now have Auto-Public access. The associated documents will not be reviewed by the securities commissions prior to their becoming public.

## **4. Newfoundland and Labrador Reference**

All references to “Newfoundland” throughout the application have been updated to “Newfoundland and Labrador”.

## 5. Alberta Securities Commission Fee Description Changes

As indicated in the September 6, 2006 Notice of Fee Increase from the Alberta Securities Commission (ASC), the ASC will implement a 20% fee increase for certain activities over a three year period commencing October 1, 2006. ## 6. Business e-mail address

A new mandatory field has been added to the Other Issuer profiles; "Business e-mail address." When updating or creating a new Other Issuer profile, the filer will be required to enter the Issuer's business e-mail address in order to submit the updated or new profile. This Business e-mail address will be reflected on the Issuer's profile information on [www.sedar.com](http://www.sedar.com) the following day.

The existing "Notice of Meeting" search criteria has been expanded to include documents filed under the document type Notice of Meeting under the "Management Proxy Materials" filing type.
